Interlend 2013 - Speaker Biographies

Conference Keynote Speakers

Professor Charles Oppenheim

Charles Oppenheim was, until he retired in 2009, Professor of Information Science at Loughborough University, and is currently a Visiting Professor at Queensland University. Previously he held posts in academia and the electronic publishing industry. He is now an independent consultant.

He has been involved in, given talks on, and published widely on Intellectual Property Rights, other legal issues relevant to the library and information professions, bibliometrics, evaluation of research quality, and on scholarly publishing trends for many years. He is copyright consultant to private and public sector bodies, including Jisc and NHS Scotland. He is a member of the Libraries and Archives Copyright Alliance, a body that lobbies both the UK Government and the European Commission on behalf of intermediaries regarding copyright matters, and of the team that negotiates licences on behalf of the UK higher and further education communities with the Copyright Licensing Agency and other licensing bodies. He is also a member of the European Commission's Legal Advisory Board. He is currently Chair of the EDINA Management Board. His recent Facet book, "The No-Nonsense Guide to Legal Issues in Web 2.0 and Cloud Computing" has received very positive reviews.

Graham Cornish

Graham Cornish worked at the British Library (and its predecessors) at Boston Spa for thirty-three years. From 1986 he managed the IFLA Office for International Lending and later also the IFLA Programme for Universal Availability of Publications (UAP). He served as assistant editor for the journal *Interlending & Document Supply* for many years. During his time with IFLA he devised the IFLA Voucher Scheme which enables libraries to carry out interlibrary transactions across national borders without having to send money. He was also the BL Copyright Officer for 18 years and now works as an independent consultant and trainer on copyright under the brand name "Copyright Circle". His book, *Copyright: interpreting the law for libraries, archives and information services*, is now in its 5th Edition. He was president of the (then) Library Association in 2000.

The British Library
